Debt Arrears Policy

This policy has been compiled recognising the difficulties placed on Headteachers in balancing the social welfare of pupils with the management of the school budget while being sympathetic to families who may be suffering financial hardship.

Dinner Money:

Dinner money should be paid on Monday for any dinners required that week.

- When a pupil has failed to produce dinner money the school may allow a meal to be provided where it is felt that this is a temporary situation, e.g. money lost on the way to school, minor domestic problem etc. Details should be recorded electronically as a record.
- 2. In the first instance, a message (message 1) via ARBOR will be sent to the parent/carer on the first day that money is owed requesting payment either via the office or online by the end of the day.
- 3. Where a pupil continues to require meals and no payment is made, the debt will increase. A meal will be provided and a message (message 2) will be sent on each day that the debt is outstanding up to a maximum of five days.
- 4. If the debt remains outstanding after five days, a further message (message 3) will be sent requesting payment by a specific date.
- 5. If the debt is paid by the specific date, letter A will be sent thanking parent/carer for payment and offering support if needed in future.
- 6. If the debt remains outstanding, letter B will be sent advising parent/carer that they need to now provide a packed lunch or collect their child to have lunch at home. Letter B will also offer support to the family if necessary. If requests for school dinners continue, the school will provide a basic meal, however the full cost will be charged to the parent/carers which will increase the amount owed. The outstanding balance must be paid within the next thirty days or the matter referred to the Chair of the Governors Finance Committee for a formal debt review.
- 7. The same process should be used if a cheque is not honoured by the bank.
- 8. If, in the opinion of the headteacher, failure to provide a meal could have serious consequences for that pupil, a meal should be provided and details recorded electronically as a record.

Wraparound Care Provision (Breakfast, After-School and Holiday Clubs)

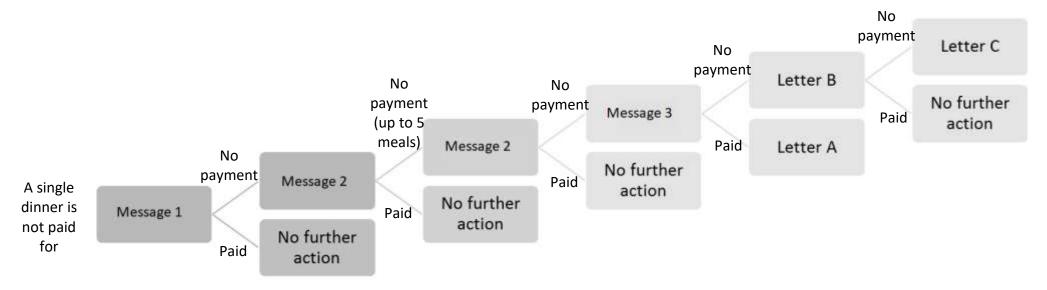
- 1. When a parent/carer has failed to pay for the provision provided, a message will be sent reminding the parent/carer that their account has a negative balance.
- 2. If this action proves unsuccessful in securing payment for the arrears, a second message will be sent to parents/carers 5 days later advising them of the amount owing and that urgent payment is required.
- 3. If the outstanding debt remains unpaid, parents/carers will be informed in writing that no more provision will be made for their child/ren within the school's wraparound care facilities until the debt is paid.
- 4. When the outstanding debt remains unpaid after another month, the debt will be referred to Chair of the Governors Finance Committee for advice
- 5. If parents/carers have difficulty clearing their arrears, it may be possible to draw up a payment plan to spread the cost of clearing the arrears. Parents/carers should speak to the Wraparound Care Manager directly to discuss the options available. Any plan would be at the school's discretion and future provision for the child/ren within wraparound care would be dependent on adhering to any agreed plan

Communication Plan for dinner monies arrears



Messages (via ARBOR) to parents/carers

Message 1: #Name has ordered a school dinner today. Please pay £ via the school office or online by the end of the day. Thank you.

Message 2: #Name has an outstanding balance of £ for school dinners. Please pay £ via the school office or online by the end of the day. Thank you.

Message 3: #Name has an outstanding balance of £ for school dinners. This will need to be paid by dd/mm/yy before any further meals can be ordered. Thank you.

Letters to parents

Letter A summary: Thanking the parent for payment. Explaining importance of swift payments. Offering support if needed.

Letter B summary: Clarifying the debt. Explaining the basic school dinner option until payment has cleared. Offering support if needed.

Letter C summary: Bespoke letter outlining the formal steps that will be taken if debt is not cleared by final deadline.

Dear name

Despite several reminders by text message, the amount of \mathcal{L} is still owing on *child's name* dinner money account.

As you can appreciate, we rely on prompt payment of dinner money in order for us to maintain and run an efficient dining room provision and a relatively small amount of money owing can soon lead to a larger debt over a surprisingly short amount of time. This can become difficult for the school, and some families, to manage.

With this is mind, we are now unable to provide a school dinner for #name until the account is cleared. In the meantime, you are welcome to provide a packed lunch or take #name home for lunch.

Should #name continue to order a school dinner, we will only be able to provide #name with a basic meal at full cost. The cost of the meal will be charged to #name's dinner money account which will further increase the amount owed. If the debt is not paid within the next thirty days, we will be forced to refer the matter to the School Governors for a formal debt review.

As a school we recognise that failure to pay debts, or provide your child with a lunch, may be a sign that a family is in need or, that a child is at risk of neglect. If you feel you may require support, or would like to talk to someone about this, please do not hesitate to contact either myself or the family support worker.
